**CLOSING DATE** for entries is 6:00 pm, Wednesday, May 29, 2024, at the Trial Secretary's home, after which time entries cannot be cancelled, accepted, or altered except for transfers as defined in the Rally Regs Chapter 1, Section 15 and Obedience Regs Chapter 1, Section 16a and 16b.

**ENTRY FEE** is per dog and includes recording fee and event service fee. "A recording fee of \$.50 (50 cents) and an Event Service Fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience, Trial or Tracking Test.
